This is to protect your privacy. We will respond to your request as quickly as possible, within four weeks at the latest.

In all cases for which your consent is the basis for a certain kind of information processing, you have the right to revoke that consent. This will have no effect on information processed in the past, but does mean that we will not be allowed to process this information going forward. It is possible that, as a result, Shibaura Europe BV may no longer be able to provide you with certain services.
